Dear Shareholder (holding Physical Share Certificate),

**Subject: NORMS FOR FURNISHING PAN, KYC DETAILS AND NOMINATION BY HOLDERS IN PHYSICALS SECURITIES**

SEBI has vide [Circular No. SEBI/HO/MIRSD/MIRSD\\_RTAMB/P/CIR/2021/655 dated 3<sup>rd</sup> November 2021](#) read with [SEBI/HO/MIRSD/MIRSD\\_RTAMB/P/CIR/2021/687 dated 14<sup>th</sup> December 2021](#)

It shall be mandatory for all shareholders holding physical securities to furnish the following documents / details to the Registrar and Transfer Agent (RTA);

- a) PAN, Address with pin code, Email Address, Mobile Number and Bank Account details in Form [ISR-1](#) and
- b) Nomination
  - I. Either,
    - Nomination through Form [SH-13](#) as provided in the Rules 19 (1) of Companies (Shares capital and debenture) Rules, 2014 **OR**
    - 'Declaration to Opt-out', as per Form [ISR-3](#)
  - II. In case of cancellation of nomination by the holder(s) through Form [SH-14](#), then 'Declaration to Opt-out' as per Form [ISR-3](#) shall be provided by the holder(s)
  - III. Securities holder(s) can change their nominee through Form [SH-14](#)

Please note that the folios wherein the above cited document / details are not available on or after **1<sup>st</sup> April 2023**, shall be frozen by the RTA. Pursuant to Central Board of Direct Taxes notifications and SEBI Press Release dated 3<sup>rd</sup> September 2021, folios in which valid PAN is not linked with Aadhar shall be frozen after **31<sup>st</sup> March 2022**. The securities in the frozen folios shall be referred by the RTA/ Company to the administering authority under the Benami Transactions (Prohibitions) Act 1988 and or Prevention of Money Laundering Act 2002, if they continue to remain frozen as on **31<sup>st</sup> December 2025**.
