

A. (i) There were no requests generated or received relating to the Transfer and/or Transmission of Shares during the year from 1st April, 2023 to 31st March, 2024.

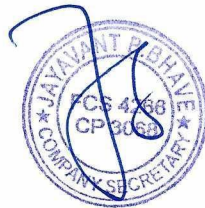
